# LEICESTER CITY COUNCIL CIVIL ENFORCEMENT AREAS IN THE CITY OF LEICESTER

Notice is hereby given that Leicester City Council in accordance with its powers under Part 6 of the Traffic Management Act 2004 intends to set from the 31<sup>st</sup> March2008 the following penalty charges in relation to parking contraventions within the City of Leicester.

A commercial vehicle parked in a restricted street in contravention of the	£70
overnight waiting ban	
Parked in contravention of a commercial vehicle waiting restriction	£70
Parked in contravention of a coach ban	£70
A heavy commercial vehicle wholly or partly parked on a footway, verge or	£70
land between two carriageways	
Stopped on a pedestrian crossing or crossing area marked by zigzags	£70

Parked in a restricted area in a car park	£70

Parked in a disabled persons parking space without clearly displaying a valid disabled persons badge in the prescribed manner	£70
Vehicle parked exceeds maximum weight or height or length permitted in the	£70
area	
Parked in a car park or area not designated for that class of vehicle	£70
Parked causing an obstruction	£70

A penalty charge of £70.00 on the issue of a Penalty Charge Notice (PCN) in accordance with Part 6 of the Traffic Management Act 2004 will be discounted to £35.00 if payment is received within 14 days of the issue of a PCN

## On Street penalty charge £50 parking contraventions:

Parked after the expiry of paid for time	£50
Parked without clearly displaying a valid pay and display ticket	£50
Parked with Payment made to extend the stay beyond initial time	£50
Parked without payment of the parking charge	£50
Parked in a residents or shared use parking place or zone displaying an invalid	£50
permit, an invalid voucher or an invalid pay & display ticket	
Re-parked in the same parking place or zone within one hour or other	£50
specified time of leaving	
Not parked correctly within the markings of the bay or space	£50
Parked for longer than permitted	£50
Parked with engine running where prohibited	£50

## Off Street -Car Parks penalty charge £50 parking contraventions:

Parked without payment of the parking charge	£50
Parked for longer than the maximum period permitted	£50
Parked after the expiry of paid for time	£50
Parked in a car park without clearly displaying a valid pay and display ticket	£50
Parked beyond the bay markings	£50
Parked in a parking place for a purpose other than the designated purpose for	£50
the parking place	

A penalty charge of £50.00 on the issue of a Penalty Charge Notice (PCN) in accordance with Part 6 of the Traffic Management Act 2004 will be discounted to £25.00 if payment is received within 14 days of the issue of a PCN

The above charges will take effect on 31st March 2008
