<p>Elected Members, including the City Mayor, are paid an annual allowance in exchange for the time and expenses they</p> <p>All figures shown above are gross payments and are subject to Income Tax and National Insurance</p> <p>Members can decline any element / increase (in full or in part) of their Allowances</p>	
<p>Basic Allowances (including Travel & Subsistence and Telecommunication & Support Allowances)</p>	<p>All Members receive a Basic Allowance, together with a Travel and Subsistence Allowance for activities within the city boundary. They also receive a Telecommunication and Support Allowance which is a contribution to council related telecommunication costs including broadband and miscellaneous items to support the member's role, such as printer cartridges</p>
<p>Special Responsibility Allowance</p>	<p>Members who take on a specific responsibilities such as a Committee Chair are paid an additional Special Responsibility Allowance. Details of these are included in the Members' Allowance Scheme which does not allow any individual to receive more than one special responsibility allowance</p>
<p>Dependant Care Expenses</p>	<p>Members may claim expenses in relation to dependant care where appropriate</p>
<p>Travel & Subsistence Outside City</p>	<p>Additional expenses can be claimed for travel and subsistence incurred outside the city boundary when undertaking approved council duties</p>
<p>Independent Persons / Members / Co-optees</p>	<p>The Council is required to appoint Independent Persons and Independent Members to support the Standards process, which has a role in governing the conduct of Councillors. There is also a statutory requirement for Co-optees to contribute to the council's activities from an education perspective, specifically as part of the council's Children, Young People and Schools Scrutiny Commission. These position receive the allowances shown above. In addition, Independent Persons can claim travel expenses</p>
