

**New Walk Conservation Area Management Plan
Representations Received During Consultation: 25th July and 6th September 2019**

The Council directly all properties in the Conservation Area with a letter detailing the public consultation. The consultation material was available online and at the City Council Customer Service Centre on Granby Street. In addition, meetings took place with representatives of key buildings within the Conservation Area, such as the Places of Worship. The first of the two public meetings was combined with the Castle Ward Community Meeting, with a further meeting arranged in advance with the ward councillors. Several engagement events took place, including: two public meetings on the 25th July and 27th August at Holy Trinity Church; two consultation sessions on New Walk itself on 8th August and 23rd August; an exhibition at St Stephen's United Reformed Church on 30th July.

	visitors alike. That said, I would like to see plans and reassurances that the project will encompass CCTV, better lighting and improved maintenance schedules to ensure that the area continues to be maintained to the standard and that repairs and cleaning are done as priority.	
9.0	One of the key areas of concern for me is Museum Square as it's right outside our doorstep, the rise in anti-social behaviour in this area is astonishing. I moved here nine years ago and since that time there has been a drastic change in this area. The square attracts a large number of drug users so we are constantly having to see either a group of addicts splayed across the benches or individuals who are so intoxicated they seem fixated in the same position for several hours. This is an area that attracts a lot of children due to the museum and it is distressing not just for the children but for the parents to have to explain what these people are doing. I would suggest that a simple solution would be to replace the existing wooden benches with metal benches with a bar through the middle, this is not only in keeping with the rest of the benches on New Walk but I believe this would act as a deterrent as the wooden benches are easy to sleep and lay on, the metal benches would not be.	Noted. Single seats are now being considered to prevent sleeping on benches and the location of them needs to be mindful of the residents each side. Therefore, they will be situated on the Museum side and the offices side, rather than New Walk and Princess Road West, which are the residential sides.
9.0	I have also seen on regular occasions that the large oak tree in the centre of the square is often used by drunken students as a challenge for them to climb, not only is this incredibly dangerous but I find it terribly disrespectful especially due to the usual damage to this tree of broken branches. I would advise you rethink the placement of benches around this tree, as this would simply provide such people a leg up to destroy this tree further.	Noted.

In practice projects come forward infrequently, so the stipulation that there should be no more than one every 24 months seems unnecessary.
